Justifications



- ¹ <u>Average number of days to complete lab service requests</u> The Department continues to decrease the laboratory backlog through implementation of the 10-point plan. As part of the plan, FDLE has purchased robotics for DNA sections across the state, developed new case acceptance guidelines, implemented more effective workload and staffing management practices, maximized overtime use, and outsourced DNA backlogs to other private, accredited labs. Aged cases are being worked to reduce the backlog, which results in inflated turnaround times for incoming cases. Overall the average turnaround times have decreased since the beginning of the year. Additionally, FDLE began offering DNA services in its Ft. Myers Regional Crime Laboratory during the second quarter, which has continued to improve the turnaround time for lab service requests.
- ² <u>Number of DNA samples added to the DNA database</u> Due to a change in legislation, the DNA Database began collection of samples for all felony convictions effective July 1. This significantly increased the number of incoming samples. The Department anticipates this performance to continue.
- ³ <u>Investigative Services measures</u> FDLE is committed to working complex, protracted high impact criminal investigations. Because of their complexity, they are lengthy and labor intensive, resulting in agents investing more hours in fewer cases over a longer period of time.
- ⁴ <u>Number of short-term investigative assists worked</u> This measure captures assistance provided to law enforcement agencies whose jurisdiction, resources or expertise may be limited. Short-term cases initiated by FDLE that do not meet the investigative criteria to qualify as a major case are also included. More assists and short-term cases were conducted than anticipated.
- ⁵ Number of domestic security concerns reported and responded to by regional domestic security task forces This measure captures the number of tips and cases entered into the In-Site database. The Regional Domestic Security Task Forces responded to all significant domestic security concerns reported by citizens, business entities, local, state, or federal law enforcement or governmental entities. Fewer tips and cases were received than anticipated.
- ⁶ <u>Public Assistance Fraud (PAF) Investigative Services measures</u> Changes in federal food stamp program policies have resulted in a decrease of the number of administrative hearing referrals received. Additionally, the PAF program is engaged in more complex criminal investigations which require more time and effort to investigate, resulting in fewer case closures.
- ⁷ <u>Number of calls for service</u> –The number of calls for service experienced by Capitol Police fluctuates throughout the fiscal year depending upon events scheduled at the Capitol Building. Additionally, due to a more proactive approach during patrol, the number of calls for service has decreased.
- ⁸ <u>Number of domestic security training courses delivered</u> Between 2002 and 2004, emphasis was placed on FDLE delivering domestic security training. As a result, most existing law enforcement personnel have received required training. Only new law enforcement officers and first responders now require training. Additionally, domestic security training courses are available online and at the local level. This has resulted in a decrease in the number of training courses provided through certified training schools.

Highlights





FDLE and Law Enforcement Partners Launch Sex Offender Alert System. Citizens can sign up to receive e-mail alert notifications when a registered sexual offender or predator moves into their neighborhood or close to any other designated location (such as a work place, a child's school, or any other location). Citizens can also monitor specific offenders and predators and will receive an e-mail alert when those registrants change their address. The service is offered statewide and at no charge. In addition to FDLE's website, system portals have been added on local law

enforcement web sites. Within 36 hours of the site being launched, over 10,500 citizens had signed up, with new registrations occurring at a rate of 1 every 5 seconds. The addition of the alert notification system was part of Florida's compliance with the federal Adam Walsh Act.

Statewide Drug Sweep Nets 757 Arrests, Major Drug Seizures. FDLE's Regional Operations Centers coordinated an intensive one-day statewide drug enforcement effort (Operation Byrne Blitz) to fight drugs and drug-related crime. The combined efforts of over 70 local, state and federal law enforcement agencies resulted in the arrest of 757 people and the seizure of more than 4.7 kilos of cocaine, 156 pounds of marijuana, 856 marijuana plants, 670 grams of methamphetamine, 908 grams of crack, hundreds of prescription pills and \$1.16



million in US currency. Officers rounded up drug traffickers, conducted highway interdictions, executed search warrants, and dismantled methamphetamine labs and marijuana indoor grow operations during the multifaceted operation. The nation-wide effort was led by the National Alliance of State Drug Enforcement Agencies and was designated to highlight the effectiveness of concentrated drug enforcement.



The North Florida Child Abduction Response Team (CART) Recognized. The US Department of Justice recognized the North Florida CART as the first team in the country to earn national certification. To earn certification, CARTs must meet rigorous performance standards in such areas as rapid activation and response, Incident Command Structure, command post operations and leads tracking. The first CART was

created in Florida in 2005. There are now has 13 teams in place across the state.

Major Retail Theft Ring Uncovered. In partnership with the Hillsborough and Polk County Sheriffs Offices and the Attorney General's Office of Statewide Prosecution, FDLE arrested 18 individuals as part of an organized group across multiple jurisdictions that shoplifted beauty products from Publix, Target, Albertson's, Winn Dixie and Wal-Mart stores and then re-sold merchandise. Operation Beauty Stop spanned seven months and investigators estimate the group is responsible for the theft of almost \$100 million in retail goods. The suspects allegedly bought and/or



ordered stolen property from a network of retail thieves for resale on the Internet, at flea markets, and other locations. All subjects were charged with RICO and conspiracy to commit RICO.

Justifications



- ¹ <u>Number of cases awarded emergency violent crime funds</u> Because of statewide reductions, the amount of funds being awarded was significantly less than expected.
- ² <u>Average number of days to complete lab service requests</u> The Department continues to decrease the laboratory backlog through implementation of the 10-point plan. As part of the plan, FDLE has purchased robotics for DNA sections across the state, developed new case acceptance guidelines, implemented more effective workload and staffing management practices, maximized overtime use, and outsourced DNA backlogs to other private, accredited labs. Aged cases are being worked to reduce the backlog, which results in inflated turnaround times for incoming cases. As the backlog decreased throughout the year, the turnaround times declined. Additionally, FDLE began offering DNA services in its Ft. Myers Regional Crime Laboratory during the second quarter, which has continued to decrease the turnaround time for lab service requests. Overall the average turnaround times have decreased by 55% since the beginning of the fiscal year.
- ³ <u>Number of DNA samples added to the DNA database</u> Due to a change in legislation, the DNA Database began collection of samples for all felony convictions effective July 1. This significantly increased the number of incoming samples. The Department anticipates this performance to continue.
- ⁴ <u>Number of crime scene service requests completed</u> FDLE responded to all requests for crime scene assistance received from local law enforcement agencies during the fiscal year. Annual requests from local agencies were fewer than anticipated.
- ⁵ <u>Investigative Services measures</u> FDLE is committed to working complex, protracted high impact criminal investigations. Because of their complexity, they are lengthy and labor intensive, resulting in agents investing more hours in fewer cases over a longer period of time.
- ⁶ <u>Number of short-term investigative assists worked</u> This measure captures assistance provided to law enforcement agencies whose jurisdiction, resources or expertise may be limited. Short-term cases initiated by FDLE that do not meet the investigative criteria to qualify as a major case are also included. More assists and short-term cases were conducted than anticipated.
- ⁷ Number of domestic security concerns reported and responded to by regional domestic security task forces This measure captures the number of tips and cases entered into the In-Site database. The Regional Domestic Security Task Forces responded to all significant domestic security concerns reported by citizens, business entities, local, state, or federal law enforcement or governmental entities. Fewer tips and cases were received than anticipated.
- ⁸ <u>Public Assistance Fraud (PAF) Investigative Services measures</u> Changes in federal food stamp program policies have resulted in a decrease of the number of administrative hearing referrals received. Additionally, the PAF program is engaged in more complex criminal investigations which require more time and effort to investigate, resulting in fewer case closures.
- ⁹ <u>Number of calls for service</u> –This measure fluctuates throughout the fiscal year depending upon events scheduled at the Capitol Building. Additionally, due to a more proactive approach during patrol, the number of calls for service has decreased.
- ¹⁰ Number of law enforcement officers trained by DARE Because of statewide budget reductions, training opportunities for DARE officers were significantly reduced, resulting in fewer officers receiving training and certification.
- ¹¹ <u>Number of domestic security training courses delivered</u> Between 2002 and 2004, emphasis was placed on FDLE delivering domestic security training. As a result, most existing law enforcement personnel have received required training. Only new law enforcement officers and first responders now require training. Additionally, domestic security training courses are available online and at the local level. This has resulted in a decrease in the number of training courses provided through certified training schools.
